**Permanent Court Time** means a court is reserved in the name and household number of a member at the same time each week from Tuesday, September 8, 2009 through Saturday, May 15, 2010, (36 weeks), except for designated holidays.

**1<sup>st</sup> Session: Sept. 8, 2009 thru Nov. 28, 2009**  
11 wks. ó Sun., Mon., Thurs. 12 wks. ó Tues., Wed., Fri., Sat.

**2<sup>nd</sup> Session: Nov. 29, 2009 thru Feb. 20, 2010**  
10 wks. - Thurs., Fri. 12 wks. - Mon., Tues, Wed., Sat., Sun.

**3<sup>rd</sup> Session: Feb. 21, 2010 thru May 15, 2010**  
11 wks. ó Sun. 12 wks. ó Mon. thru Sat.

**PCT Option 1)** Offers existing PCT members **priority renewal** for the 2009-2010 season. Same court, same time as the 2008-2009 season. PR PCT court fees \$12, \$18, \$24.

- Fees for the entire 36 week season must be prepaid by 6 pm on April 23, 2009. No installment billing will apply. Contracts will not be honored without full payment.
- If the PCT is a Pro lesson court and the existing student(s) choose not to renew, the Pro will have the option of securing another student on that court with the same prepayment and date as above.
- Cash, cheque, credit card only. No house charges. No refunds!

**PCT Option 2)** After April 23 remaining courts may be booked as PCT on a first come, first served basis.

- Prepay for the season PCT rates are \$12, \$18, \$24. Cash, cheque, credit card only. No house charges. No refunds.

**PCT Option 3) Installment billing** is available for any booking made after April 23, 2009 with the addition of \$1 per hour per week court fee.

1. Pay for the first session of court time up front. Receive an invoice for the second & third installments. Notice must be given 30 days prior to the start of a new session if you want to drop your PCT. This drop is for the entire court only. Any individual who wants to drop their spot from PCT, must contact other players in their group. The billing office will not handle individual adjustments. Court rates would be \$13, \$19, \$25.

**PERMANENT COURT TIME RESPONSIBILITY**

1. It is the responsibility of the member in which PCT is listed to:
  - a. Provide Club with names, phone numbers and household numbers of those playing on the courts by August 31, 2009 even if split billing for 2<sup>nd</sup> or 3<sup>rd</sup> session is not desired.
  - b. Indicate if the court time is to be split billed and/or the name of a Tennis Professional involved if applicable.

**SPLIT BILLING NOTIFICATION DEADLINE**

2<sup>ND</sup> SESSION ó OCTOBER 29, 2009      3<sup>RD</sup> SESSION ó JANUARY 21, 2010

**A \$10 charge will occur for any changes in billing after the deadline.**

- c. Notify service desk of a non-member substituting on the PCT on a particular date. A guest fee must be paid, a guest pass used or PCT listed account will be billed.
2. **ALL PARTICIPANTS MUST HAVE CURRENT MEMBERSHIPS AND MUST SELECT SAME OPTION.**
  3. If you are unable to use your PCT on a particular date, the Club will try to sell it. If successful, a refund will be credited to the first party named on the court sheet at the Welcome Center desk. PCT courts sold to Junior or Senior õwalk-onsõ will be credited at the Junior or Senior rates.
  4. To obtain release from PCT responsibility, **written notice** must be received before October 29, 2009 to be released from 2<sup>nd</sup> session, or by January 21, 2010 for 3<sup>rd</sup> session. Cancellation notice after these dates, means courts can only be put up for sale on a weekly basis.
